HOW DOES IT WORK?

You distribute our straight-forward claims packs to your technicians who then return to us in the envelopes we provide, along with evidence of their tool purchases (either receipts or statements from suppliers). We then deal directly with each of them at their home address.

WILL IT TAKE UP A LOT OF MY TIME?

No. Once you have distributed the claim packs we do the rest. If anyone has any questions before, during or after the claim process just refer them to our freephone number. Once you have agreed to offer tax refunds to your technicians we can deal directly with service managers or an admin contact to coordinate delivery of the service.

WILL THE REVENUE TARGET MY COMPANY IN THE FUTURE?

Absolutely not. We have pioneered these claims, which are now accepted by HM Revenue & Customs in an agreed format. The claims are legitimate and 100% compliant with taxation legislation, we have yet to have a claim refused. The claim is between the taxpayer and the HMRC, the employer is merely coincidental.

WHAT WILL IT COST THEM?

We charge only when we secure a refund. Our fees on a no win no fee basis are 30%+vat of any refund we secure. This fee is simply subtracted from the refund and balance forwarded to the client.

HOW LONG WILL IT TAKE TO GET MY TECHNICIANS THEIR MONEY BACK?

Typically 6-10 weeks from receipt of the claim to delivery of the cheque, this varies from tax office to tax office. We can provide you with a clearer timescale once we know which office you deal with.

HOW MUCH MONEY WILL THEY GET BACK?

In previous cases we have secured 15-20% of the total cost of tools since 1997. Most refunds are in the £500-£1500 range.
